

# **General Policies**







### 1. Definitions

In this **Policy**, the following capitalized terms shall have the meanings ascribed to them.

- 1.1. **AED** means United Arab Emirati Dirhams:
- 1.2. **Authority** means the Sharjah Media City Free Zone Authority established in the Emirate of Sharjah pursuant to Emiri Decree No. 11 of 2017;
- 1.3. **City** means the Sharjah Media City Free Zone Authority established in the Emirate of Sharjah pursuant to Emiri Decree No. 11 of 2017;
- 1.4. **Company** means a limited liability company or a branch incorporated in the **City** in accordance with **Regulations**;
- 1.5. Competent Authority means any UAE or Emirate of Sharjah governmental, judicial or regulatory authority;
- 1.6. **Employees** means a person employed by the **Company** who is the subject of a **Sponsorship**;
- 1.7. Policy means this General Policies including its appendices;
- 1.8. **Regulations** means the prevailing Sharjah Media City Free Zone Authority Companies and Licensing Regulations and all other regulatory instruments promulgated by the Authority;
- 1.9. Representatives mean all Company investors, directors, managers and Employees;
- 1.10. **Shams** means Shams Customer Servicing LLC incorporated on 23-Feb-2017 in Sharjah Media City Free Zone under License Number: 0217002/1;
- 1.11. **Sponsorship** means the sponsorship of **Employees** by **Authority** in accordance with **UAE** Federal Law No (6) of 1973 as amended from time to time and **Regulations** for the purpose of residence and employment in **City**;
- 1.12. **UAE** means the United Arab Emirates.
- 2. The Representatives shall read and adhere to the Policy.

## 3. Regulations

- 3.1. The Company will adhere to Regulations and its amendments and any other policies issued by the Authority.
- 3.2. Subject to the provisions of this policy, the **Authority** reserves the right to impose financial penalties, pursue legal actions, cancel **Company**'s license and cancel **Employees** residence visa.

# 4. Anti-Money Laundering

- 4.1. The Company will adhere to UAE Federal Law No (4) of 2002 and any of its updates or amendments.
- 4.2. The Company will adhere to UAE Federal Law No (1) of 2004 and any of its updates or amendments.
- 4.3. The Company and its Representatives agree to provide any information, data, document or otherwise that Shams, the Authority or any other Competent Authority may request for any purpose whatsoever without unreasonable delay.

- 4.4. The **Authority** shall assume no liability for any penalties, losses or damages that may arise as a result of any unreasonable delays in the provision of information, data, documents or otherwise by the **Company** and/or its **Representatives**.
- 4.5. Subject to clause 47.1 and clause 47.3 of the Companies Regulations 2017, The **Company** and its **Representatives** acknowledge that any failure to supply information, data and/or documents, whether at the request of **Shams**, the **Authority**, any **Competent Authority** or otherwise, shall result in the cancellation of the **Company**'s license.
- 4.6. The **Company** and its **Representatives** further agree to supply accurate, current and authenticated information pertaining to the **Company** and its **Representatives**. The **Company** will be responsible and liable for any false and misrepresented information provided.

## 5. Employee Sponsorship Agreement

- 5.1. **Authority** shall sponsor **Employees** to be supplied to the **Company** in the **City** and **Company** accepts **Sponsorship** of the **Employees** by the **Authority** subject to **Regulations**.
- 5.2. **Authority** shall prescribe, at its sole discretion, the number of **Employees** that **Company** can employ.

## 6. Authority Rights

6.1. **Authority** reserves the right to reject any application for a **Company** or its **Employees** at any time and without notice.

## 7. Fees and Refunds

- 7.1. **Authority** reserves the right to suspend all services to **Company** and withdraw the **Company**'s license if there are any overdue invoices.
- 7.2. **Company** shall settle all invoices raised by the **Authority** without any setoff or deduction and free and clear of all taxes and in a manner so that the **Authority** shall receive full value in cleared funds.
- 7.3. **Authority** reserves the right to reject any refund application.
- 7.4. **Authority** reserves the right to enforce an administrative fee of **AED** 1,000 before issuing any refunds to **Company**.
- 7.5. **Authority** reserves the right to reject any refund applications if the Immigration Card of **Company** has been rejected by the General Directorate of Residency and Foreign Affairs due to any pending criminal or civil cases against the **Representatives** of the **Company**.
- 7.6. **Authority** reserves the right to reject any refund applications if the **Company** fails to provide any attested original documents requested that of the **Representatives**.

# 8. Liability

- 8.1. The **Authority** is not liable for:
  - 8.1.1. any delays or rejection of applications from the General Directorate of Residency and Foreign Affairs or any other **Competent Authority**.

- 8.1.2. any delays or rejection of applications for external approval from any **Competent Authority**.
- 8.1.3. any act, default or omission on the part of a **Representative** including without limitation any breach of any restraint of trade or non-competition covenant that may be contained in the employment contract of the **Employees**.
- 8.2. **Company** is responsible to obtain all necessary approvals from relevant **Competent Authorities** where and when is required.

### 9. License Cancellation

- 9.1. The **Authority** shall assume no liability that may arise as a result of cancellation of the **Company's** license or any associated **Sponsorship** by **Authority** due to a breach of **Regulations** by the **Company**.
- 9.2. The **Authority** shall assume no liability that may arise as a result of cancellation of the **Company**'s Immigration Card due to a breach of **Regulations** and as per the policies of **Competent Authority** and will not be able to reissue an Immigration Card for the same **Company**.
- 9.3. The **Authority** reserves the right to apply any monetary deposits paid to **Shams** towards settlement of any fees, fines, penalties, charges or otherwise.
